SUBJECT: AMENDMENTS TO: THE CUSTOMS (FEES) REGULATIONS, REGULATION 123 OF THE CUSTOMS REGULATIONS AND THE CUSTOMS OFFICERS (OVERTIME) REGULATIONS.

All importers and exporters are advised that consequent to salary increases for the period 2011 to 2013, the Customs (Fees) Regulations, the Customs Regulation 123 of the Customs Act, Chap. 78:01 and the Customs Officers (Overtime) Regulations were amended by the President under Section 263(1) of the Customs Act, Chap. 78:01 and have been published as:

- Legal Notice No.97 of 2016 The Customs (Fees) (Amendment) Regulations, 2016
- Legal Notice No.98 of 2016 The Customs (Amendment) Regulations, 2016, and
- Legal Notice No.99 of 2016 -The Customs Officers (Overtime) (Amendment) Regulations, 2016.

The effects of these amendments are reflected in the tables below and serve to:

- (I) Increase the Rates of Overtime Fees, and
- (II) Increase the Charges for part-time Officers in Private warehouses.

The implementation of the revised Overtime Fees and Charges will take effect from August 1st, 2016.

Regulation 123

In the case of a private warehouse which is **not** required to be opened every day, the Comptroller may arrange for supervision to be exercised by Officers appointed by him and in such case the warehouse-keeper shall pay to the Comptroller, a sum of **\$53.56** for each hour or part of an hour during which the warehouse is kept open on any day. The **minimum** sum a warehouse-keeper shall pay per day is **\$107.12** (two hours).
