NOTICE TO IMPORTERS NO. 24 OF 2016

SUBJECT: LEGAL NOTICE NOS. 159, 160, 161 AND 162 OF 2016 WHICH AMEND:

THE CUSTOMS ACT, CHAP. 78:01;

THE EXCISE (GENERAL PROVISIONS) ACT, CHAP.78:50; AND

THE CUSTOMS (IMPORT DUTY) (CARIBBEAN COMMON MARKET) ORDER

The attention of all importers is drawn to:

- 1. The Customs (Common External Tariff) (Amendment) Order, 2016, made by the President under Section 8 of the Customs Act, Chap. 78:01 and published as **Legal Notice No. 159 of 2016**. The effect of this amendment is to increase the Rates of Import Duty applicable to the goods of Tariff Heading Numbers enumerated in the said Legal Notice, of **Non Caricom Origin** being imported into Trinidad and Tobago.
- 2. The Customs (Import Duty) (Caribbean Common Market) (Amendment) Order, 2016, made by the President under Section 7(1) and 10 of the Customs Act, Chap. 78:01 and published as **Legal Notice No. 160 of 2016**. The effect of this amendment is to increase the Rates of Import Duty applicable to the goods of Tariff Heading Numbers enumerated in the said Legal Notice, of **Caricom Origin** being imported into Trinidad and Tobago.
- 3. The Excise Duty (Alcoholic Beverages) Order, 2016, made by the Minister under Section 13(2) of the Excise (General Provisions) Act, Chap. 78:50 and published as **Legal Notice No. 161 of 2016**. The effects of this Order are:
 - i. to revoke The Excise Duty (Alcoholic Beverages) Order, 2009; and
 - ii. increase the Excise Duty applicable to the goods of Tariff Heading Numbers enumerated in the said Legal Notice, **for consumption in** Trinidad and Tobago.
- 4. The Excise Duty (Tobacco Products) Order, 2016, made by the Minister under Section 13(2) of the Excise (General Provisions) Act, Chap. 78:50 and published as **Legal Notice No. 162 of 2016**. The effects of this Order are:
 - i. to revoke The Excise Duty (Tobacco Products) Order, 2009; and
 - ii. increase the Excise Duty applicable to the goods of Tariff Heading Numbers enumerated in the said Legal Notice, **for consumption in** Trinidad and Tobago.

These measures will take effect from October 20th, 2016.
